VOLUNTARY ANNOUNCEMENT – DISPOSAL OF SHARES BY SUBSTANTIAL SHAREHOLDER

The board (“**Board**”) of directors (“**Directors**”) of Tai Kam Holdings Limited (the “**Company**”) has been informed by Classy Gear Limited (“**Classy Gear**”) that on 18 October 2018 and 19 October 2018, it has disposed of in aggregate 138,330,000 shares of the Company on open market for a total consideration of approximately HK\$13,201,000 (the “**Disposal**”).

Immediately before completion of the Disposal, Classy Gear owned a total of 138,330,000 shares of the Company, representing approximately 17.29% of the issued share capital of the Company. The shares disposed of from 18 October 2018 to 19 October 2018 represent in aggregate approximately 17.29% of the issued share capital of the Company. Upon completion of the Disposal, Classy Gear no longer holds any shares of the Company.

To the best of the Company’s knowledge, information and belief, having made all reasonable enquiries, the Company is not aware of the identities of the counterparties of the Disposal or of their respective principal business activities.
